REQUEST OR ISSUE: Approve the amendment to the IGA with Boulder County Sheriff's Office Resolution 2018-07

RECOMMENDED ACTION / NEXT STEPS: Approve Resolution 2018-07,

FISCAL IMPACTS: This position was not funded in 2018

BACKGROUND INFORMATION:

For many years, the Town of Lyons has contracted with Boulder County for law enforcement services rather than maintaining its own police department. The arrangement has worked well over the years, and has always been governed by an intergovernmental agreement. Historically, the term of the IGA has been indefinite, or until terminated by either party or superseded by a new agreement. The current IGA was approved in 2015.

The proposed amendment removes the sections reading:

"In addition, the Sheriff will ensure that there is one deputy sheriff assigned with responsibility to provide law enforcement and public safety services for the Town specifically. Services will be provided 42 hours per week in accordance with Sheriff's Office schedule."

And, “A source for obtaining gasoline for motor vehicles used by the Sheriff’s Office in the vicinity of the Town.”

Additional minor changes were made by legal staff, consisting of formatting revisions.

The proposed amendment was the result of the Board of Trustees voting to remove the assigned Lyons officer in 2017.
