Name	Details
RTD Eco Pass Program	Price has been determined. Communication has been sent to customers. Front desk documentation has been created and Linda/Brandi have reviewed. Working with Express Bill Pay to determine the online payment process.
EV Charging Stations	Waiting to get a quote from Verdek to fix head unit. EvConnect sent a quote to fix head unit – 3,778.20
Garden in a box	Town of Lyons needs to sign contract. Still waiting on Boulder County to send Sustainability grant check to Town of Lyons
Arbor Day	Contacted arbor day and filled out event application. Waiting to hear back for more planning details.
Chipping	Combination of Boulder County and Town of Lyons have budgeted 8k for chipping event. Need to determine event details and timing.
Data Analysis	Waiting to hear back from Brandi on whether we can get 5 years of energy and water data for residential, commercial, and municipal usage Spoke to Paul Glasgow – he said the new AMR meters will be installed at town hall, depot, and public works so we will be able to measure energy and water usage for each municipal building.
2019 Sustainability Impact Report	Kim is working on a 2019 Town of Lyons report. I am not sure what the expected due date is for this.
2020 Water Conservation	Initial Planning for 2020 Lyons Water Conservation Programs is underway
Zero Waste	Eco Cycle is working on zero waste signs for the Town to use at special events. Zero waste education campaign – I sent an email to Lyons Middle/High school assistant principle. Waiting to hear back whether there is a good group that will be able to help with zero waste education at summer concert series and Lavern Johnson park during the summer. Nothing new on the PAYT. I would like to mandate haulers to report their annual waste hauling to Boulder County's Retrac. I plan to discuss with SFC on Thursday February 13 th .
Recycle Center	There's been additional reports of dumping.
Spring Clean Up	Initial planning efforts are underway. As soon as we have a confirmed date, I will let you know and we can send out communication.
MEAN electrical provider	MEAN has announced they have a goal of moving to 100% renewable energy by 2050. By 2050, MEAN's bonds (certainly the bonds that Lyon's is committed to) will be expired.
