I. REQUEST OR ISSUE:

This resolution ratifies a Third Amendment with Murraysmith, Inc. for the Design Services for the 4th Ave Pedestrian Bridge, Trail Connections and Street Improvements Project.

III. FISCAL IMPACTS:

Expenses for this Professional Services Contract are eligible for reimbursement through the Department of Housing and Urban Development Community Development Block Grant Disaster Recovery (“CBDG-DR”) administered by the Boulder County Collaborative under the Intergovernmental Agreement between the Town of Lyons and the City of Longmont under INF-00072. A grant from Safe Routes to School will be funding construction for the project.

IV. BACKGROUND INFORMATION:

4th Ave Pedestrian Bridge, Trail Connections, and Street Improvements Project Scope:

The conceptual improvements connecting the pedestrian bridge include regrading and adding sidewalk improvements on the east and west side of 4th Avenue from Evans Street to High Street, including installation of new sidewalk, driveways, and curb cuts. 4th Avenue crosses the Colorado Department of Transportation (CDOT) right of way along US-36 and may require coordination and approvals.

About This Amendment:

Due to construction delays, the contractor needed additional time to complete the scope of work. This amendment authorizes an extension until June 30, 2022, at no increase to the price of the contract.
