RESOLUTION 2022-51**

**A RESOLUTION OF THE TOWN OF LYONS, COLORADO AWARDING
A CONSTRUCTION AGREEMENT FOR THE 2022 LYONS BOHN DIRT JUMP BIKE PARK
RESTORATION AND RENOVATION PROJECT WITH THE JUMP DOCTORS, LLC.**

WHEREAS, the Town of Lyons (the “Town”) has the authority to enter into contracts for any lawful municipal purpose pursuant to C.R.S. § 31-15-101; and

WHEREAS, the Town desires to enter into a contract for Construction Services for the 2022 Lyons Bohn Dirt Jump Bike Park Restoration and Renovation Project (“Project”); and

WHEREAS, the Town budgeted for the project in its 2022 Town of Lyons budget through the Parks Fund Capital Projects at \$47,000 is recommending that any overage (anticipated to be \$762 per the proposal) be absorbed in the 2022 Parks operating budget from the Building, Maintenance and Grounds or Maintenance and Supply line items. If funds are not available in whole or part from the Parks operating budget, is recommended consideration of the overage be absorbed from the Conservation Trust Fund.

WHEREAS, the Town advertised Request for Proposals on BidNet on March 29, 2022, and received bids on the due date of April 19, 2022; and

WHEREAS, Town Staff evaluated the bids received to determine the scope of work and cost are both reasonable and necessary for the Project and determined The Jump Doctors, LLC. (“Contractor”) was the qualified bidder; and

WHEREAS, the Town Staff and the Town Consulting Engineer recommend that the Town award the Agreement for work based on the Contractor’s Bid; and

WHEREAS, the Board, after full consideration of the proposed agreement and the recommendation of the Town Staff and the Town Consulting Engineer, finds that the bid submitted by The Jump Doctors, LLC. qualifies that company as the lowest, qualified bidder; and

WHEREAS, the Town Board of Trustees desires to approve the Construction Agreement in substantially the form attached hereto as Exhibit A for the not-to-exceed amount of **FORTY-SEVEN THOUSAND SIX HUNDRED TWENTY DOLLARS AND ZERO CENTS (\$47,620.00)** to have the Contractor perform the work described in the Construction Agreement.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE TOWN OF LYONS, COLORADO:

Section 1. The above recitals are hereby incorporated by reference

Section 2. The Town Board of Trustees hereby:

- (a) Awards the Construction Agreement for the Project to the Contractor.
- (b) Approves the Construction Agreement for a total not-to-exceed amount of **FORTY-SEVEN THOUSAND SIX HUNDRED TWENTY DOLLARS AND ZERO CENTS (\$47,620.00)** in substantially the form attached hereto as **Exhibit A**.
- (c) Authorizes the Town Administrator and the Town Attorney, in consultation with the Mayor, to make such changes as may be necessary to correct any non-material errors

or language in the Construction Services Agreement that does not increase the obligations of the Town.

(d) Authorizes Town Staff to complete and send to the Contractor the completed Construction Agreement for review and signature.

(e) Authorizes the Mayor or Mayor Pro Term to execute the complete Construction Agreement on behalf of the Town after the Contractor has signed the Construction Agreement and the Town Clerk to attest such signature.

Section 3. This Resolution shall take effect immediately upon adoption.
