I. BACKGROUND

On February 7, 2023, the Clerk's office received an application from the above-referenced Applicants to Relocate their Retail & Medical Marijuana Infused Products Manufacturer License to be located at 1040 5th Ave Unit 6. Applicants are currently licensed and based out of Boulder, CO. Per Ordinance 952, no more than 2 Marijuana Infused Products (MIPS) business licenses shall be issued, and the approval of this application would be the first MIPS licenses issued and would cap that number.

The location is zoned General Industrial which does allow for this type of use. The site was previously housed by a hemp extraction business and the site is built out for this exact type of use. There will be no cannabis extraction on site, they contract that out. They will make several batches of product and then spend the next six months selling the product.

Applicants are updating their Sales Tax License to reflect the new location and will have that in place before they open for business in June of 2023.

Applicants have submitted all required documentation, completed background check requirements have been reviewed and approved by the Colorado Bureau of Investigation and Boulder County Sheriff's Office. The Applicants are leasing the premises.

On March 17, 2023, Town Staff along the and Boulder County Sheriff did an onsite inspection with applicant.

Applicants are actively working with Town of Lyons Building Department and Lyons Fire to ensure all requirements are met and they are in full compliance with local codes. They need approval of the relocation / license before they can make the move.

Staff is working with the State Marijuana Enforcement Division on this relocation application and have no issues.

The Town posted notice at the location on March 9, 2023 and posted online on March 9, 2023. The Clerk's Office has not received any objections to this new application to date.
