I. REQUEST OR ISSUE:

This resolution approves a Sixth Amendment to the professional services agreement with Murraysmith for the CDOT and CDBG-funded Safe Routes to School Ped Bridge project.

III. FISCAL IMPACTS:

Expenses for this Construction Agreement are eligible for reimbursement through a Community Development Block Grant (CDBG) and Colorado Department of Transportation (CDOT) and other grants along with other grants and Town funds.

IV. BACKGROUND INFORMATION:

About This Project:

This project scope includes sidewalk improvements along 4th Ave from Evans Street to High Street, constructing a crusher fine path going south from Evans to Bohn Park, and finally the construction of a pedestrian bridge to make this connection.

About This Amendment:

This Amendment is an increase to the contract for engineering services.

The project has experienced delays due to one of the two original caissons not passing the required strength test. Per CDOR specifications and guidance of the design consultants, additional testing was performed to confirm voids in the concrete. This would assist in determining if the caisson could be repaired or if a new caisson would need to be poured. It was determined that a third caisson was needed and poured per direction from the design consultants. In addition, because of material delays for the block retaining wall, it was decided to construct a pour in place concrete wall. All of these design changes required engineering services, which resulted in additional fees.
