I. REQUEST OR ISSUE:

This resolution awards and approves a construction agreement with Mountain Constructors, Inc. for the US36-Broadway Improvements and Multimodal Trail. Town staff is recommending the award of the base bid of \$1,856,423.03 and the bid alternate of \$55,137.50 for a total award of \$1,911,560.53. The bid alternate includes the paving of the Frontage Road on the 400 & 300 block of Broadway.

II. RECOMMENDED ACTION / NEXT STEP:

Approve Resolution 2023-31.

III. FISCAL IMPACTS:

Expenses for this Construction Agreement are eligible for reimbursement by the Colorado Department of Transportation (CDOT) through the Denver Regional Council of Governments (DRCOG) program. Other funding includes Revitalizing Main Street (RMS), Stimulus Funds, and Town funding.

IV. BACKGROUND INFORMATION:

The purpose of this project is to promote Economic Development along with town connectivity and safety. To promote economic health, the scope of this project includes roadway work on Broadway to allow for 53 parallel parking spaces. Along with constructing a 10-12' multimodal trail extending from Hwy36/5th Ave to 2nd Ave for connectivity and safety.
