**I. BACKGROUND**

On June 22, 2023, the Town Clerk received an application form the above-referenced applicant for a Transfer of Ownership of a Hotel and Restaurant Liquor License located at 442 High St Unit 2. FARRA is a new Spain and Latin American restaurant that will be serving food and wine that recognizes those regions. Applicant will have food available, meeting C.R.S 12-47-109. They are currently working with Boulder County to obtain their restaurant and food vendor licensing. They are also in the process of obtaining their business license with the Town of Lyons.

Applicant has submitted all required documentation, completed all fingerprinting and background check requirements have been reviewed and approved by the Boulder County Sherriff's Department. Staff will conduct an on-site inspection of the premises upon completed renovations and State approval. Staff has provided applicant with the State Liquor Code provisions affecting their class of license. The anticipated opening date of FARRA is August. A temporary license was issued on June 26, 2023, for a period of 120 days, as the applicant has submitted all the required paperwork and fees.

The Town posted notice at the location on June 23, 2023, and published on June 23, 2023. The Clerk's Office has received no objection to this application to date.
