This resolution approves a Second Amendment to the construction agreement with Mountain Constructors by a grant agreement with CDOT (Colorado Department of Transportation) for the US36/Broadway Improvements and Multimodal project.

IV. BACKGROUND INFORMATION:

About This Project:

This project scope includes widening of US36/Broadway to add parallel parking spaces in the 400 and 300 blocks of Broadway. As well as construct a multimodal connection from 5th Ave to connect to the existing arterial trail along US36 at 2nd Ave.

About This Amendment:

This Amendment is an extension to June 28, 2024.

The project is substantially complete; however, the Town and CDOT have requested additional work that was not in the original scope therefore requiring an extension. The additional work requested requires time to order additional materials and scheduling of subcontractors to complete the work, therefore additional time is needed. Once these items are completed this will complete the entire scope of the project.

- Stair railing
- Ped and bicycle symbols on Railroad
- Red curb paint and letter stenciling on frontage road
- One additional ped push button assembly
