We pride ourselves on our knowledgeable and experienced team of sawyers to get all jobs done safely and in a timely manner. Along with the safety of our customers we never allow the safety of our workers to be compromised. We use the safest methods of timber felling and extraction that we can and minimize the impact that we are making on the land.

Objectives:

To removal all dead standing trees between the ditch line and Lyons Valley Park neighborhood which is approximately 1.75 to 2 acres.

To remove all down trees in the same area.

To reduce fuel loading and ladder fuels for wildfire.

Methods of Removal:

Felling Trees: We currently use gas powered chainsaws to manage trees. This is the lowest impact and most efficient method for the work provided. All sawyers have completed the (32hr) NWCG S-212 chainsaw class

Slash and Bole Wood Removal: slash produced will be chipped back into the area which will not exceed 3 inches in depth. Bole wood (6 INCHES AND GREATER)will be removed from site. Bole wood and slash will be moved by medium size machinery (mini excavator and skid steer).

Insurance:

All personnel working for Healthy Forest have been formally trained in all tree felling procedures. Safety is our number one priority, and all Sawyers will use all required safety equipment during operations. Hard hats are to be worn by everyone while on the active job site.

A copy of our liability insurance will be provided at the landowner's request.

Healthy Forest carries workman's comp for its employee.

Payment

Invoices will be submitted for payment following the completion and inspection of each unit of the project and a walk-through inspection of the project by the landowner accompanied by the foreman of Healthy Forest Mitigation Services.

Acceptable forms of payment are cash and check. Payment will be due within 30 days of receiving the invoice. A seven-day grace period can be granted but failure to pay in the allotted time frame will result in an additional 10% of the total bill added as a late fee. Bills not paid within the 90-day time frame will be sent to collections at the landowner's expense.

Proposed Work:

Removal all dead standing trees as well as dead trees on the ground (greater than 2.5 inches) in the predetermined area above Lyons Valley neighborhood. Work is estimated to be completed by July 4, 2024. Due to the steep slope most of the dead trees, it will be necessary to use machinery for extraction.

HFMS requests that while work is being performed the trail be closed for safety.

Prior to start of project HFMS requests that a Lyons representative marks the project boundaries to eliminate accidental cutting on non-Lyons properties.

Safety:

Haz-mat containment will be on site and in accordance with state guidelines. BLS medical kits will accompany personnel in areas of operations. Fire fighting tools will be in close proximity to action area in the event of a fire.
