- Successful 4th Annual Artisan Market on September 7, featuring nearly 50 vendors. Small modifications for improvement for next year.
- St Vrain Invitational Cross Country Events – Sept 20 and Sept 21 with 900 and 1,700 participants expected, each day, using the Lyons Middle Senior and Bohn Park Multi Use field and the 10 acres south of the dog park. Another regional cross-country event being held on October 24 and October 26.
- The Quarterly Community Town hall-style Update will be held on Wednesday, September 25, at the Lyons Regional Library from 6:30 to 7:30 p.m. The BOT will provide 15-20 minutes of updates, and the audience will have 40 -45 minutes to ask questions.
- The fall senior picnic was held on September 11, 2024, at LaVern Johnson Park, with 40 local area seniors in attendance. It is a nice way for our seniors to catch up, visit with each other, and share a picnic lunch.
- A Local Diversion Day Event is planned for Saturday, Oct 19 from 9 am – noon at the public works facility. This will include the disposal of paint, hazardous household materials, e-waste, recycling items, yard waste, and more.
- Rave to the Grave special event application for LaVern Johnson Park is being reviewed. Date is planned for Saturday, Oct 19, in the evening.
