- I. **REQUEST OR ISSUE:** Consideration of Approving an amendment to an approved Development Agreement (Resolution 2024-72) for 501 Main Street (not yet signed by the Applicant), also known as the Riverbend property.
- II. **BACKGROUND:** . The developer is proposing amended language to the presented development agreement. It is limited to Section 2.2.a.x and is as follows:

*Proposed / Edited Language*

Neither amplified nor non-amplified brass horns (saxophone, trumpet, trombone, etc.) or non-electronic drum sets can be used outside on the Property. With the exception of Town of Lyons approved special events. ~~Clarinets, harps, flutes, and electronic drum sets are permitted outside until 8 p.m. in compliance with the requirements of this Agreement and within the Town's noise ordinance.~~

*Clean Language*

With the exception of Town of Lyons-approved special events, neither amplified nor non-amplified brass horns (saxophone, trumpet, trombone, etc.) nor non-electronic drum sets can be used outside on the Property.

- III. **RECOMMENDED ACTION / NEXT STEPS:** Staff recommends that the BOT discuss the amendment as proposed. This amendment clarifies the language as proposed, discussed, and approved by Resolution 2024-72. It also maintains that no amplified music (Single-mic exempted) will be played after 8 p.m.

**IV. FISCAL IMPACTS:** No fiscal impacts are foreseen at this time.

**V. LEGAL ISSUES:** The town attorney has reviewed the proposed language and believes that it still allows for confusion on how long non-amplified music can be played outside. According to a strict reading of the PUD, nothing is allowed outside after 8:00 pm.

**VI. CONFLICTS OR ENVIRONMENTAL ISSUES:** No conflicts or environmental issues are foreseen at this time.
