RESOLUTION NO. 2024-90**

**A RESOLUTION OF THE TOWN OF LYONS, COLORADO,
APPROVING AN EXTENSION TO THE BOULDER COUNTY
INTERGOVERNMENTAL DEVELOPMENT AGREEMENT**

WHEREAS, the Town of Lyons (“Town”) is a statutory municipality organized under the laws of the State of Colorado; and

WHEREAS, pursuant to C.R.S. § 29-1-203 *et seq.* and Article XIV of the Colorado Constitution, the Town and Boulder County, Colorado (“Boulder County”) are authorized to cooperate or to enter into contracts with each other to provide any function, service, or facility lawfully authorized to each, and any such contract may provide for the sharing of costs; and

WHEREAS, the Town and Boulder County (collectively “the Parties”) are authorized to plan for the use of land as provided by law; and

WHEREAS, the Parties entered into the Lyons Planning Area Comprehensive Development Plan Intergovernmental Agreement (“Agreement”), effective May 15, 2012; and

WHEREAS, the Agreement is referred to as the IGA (“IGA”) and expired by its original terms on May 15, 2022; and

WHEREAS, pursuant to Resolution 2023-68, the IGA was amended (“First Amendment”) and is now set to expire on November 15, 2024; and

WHEREAS, under Section 11 of the IGA, both parties can and must agree to amendments to the IGA; and

WHEREAS, the Parties wish to extend the IGA through June 30, 2025; and

WHEREAS, the Parties have been actively discussing updating the IGA and adopting a long-term extension with a stated desire to execute a mutually favorable long-term extension by March 31, 2025; and

WHEREAS, the extension of the IGA will allow sufficient time to negotiate and adopt a long-term extension of a revised IGA that reflects the goals of the 2023 Lyons Thrive! Comprehensive Plan and other adopted plans and those of Boulder County and its adopted plans and to consider recommendations made by the BOT’s appointed IGA Task Force; and

WHEREAS, the Board of Trustees for the Town of Lyons desires to approve an amendment to the IGA and to extend its effective date until June 30, 2025.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE TOWN OF LYONS, COLORADO:

Section 1. The above recitals are hereby incorporated by reference.

Section 2. The Town Board of Trustees hereby:

(a) Approves a second amendment to Lyons Planning Area Comprehensive Development Plan Intergovernmental Agreement between the Town of Lyons and the County of Boulder (the "Amendment") in substantially the form attached hereto as **Exhibit A**.

(b) Authorizes the Town Administrator and the Town Attorney, in consultation with the mayor, to make such changes as may be necessary to correct any non-material errors or language in the Amendment that do not increase the obligations of the Town.

(c) Authorizes the Mayor to execute the Amendment and the Town Clerk to attest to the Agreement when it is in final form.

Section 3. This Resolution shall take effect immediately upon adoption.
