1. **ITEM:** **Ordinance 1177** – an Ordinance of the Town of Lyons, Colorado, Amending Article 4 of Chapter 13 of the Lyons Municipal Code for the Purposes of Increasing the Service Rates and Charges for Wastewater Utility Service By the Consumer Price Index (CPI)

 INFORMATION

I. REQUEST OR ISSUE:

Increase service rates and charges in the wastewater enterprise fund by 3% to cover increased expenses from inflation as required by Lyons Municipal Code section 13-4-70 (e.) Periodic CPI rate adjustment.

II. RECOMMENDED ACTION / NEXT STEP:

Approve Ordinance 1177 on the first reading, schedule a public hearing, and second reading.

III. FISCAL IMPACTS:

This rate increase is estimated to bring an additional \$28,500 in revenue to the water/wastewater enterprise fund.

The Lyons Municipal Code requires adjusting the wastewater fund rates and charges in accordance with the Consumer Price Index (CPI). The CPI for 2025 is estimated to be 3%. We also have a recent facilities master plan showing the improvements needed for wastewater treatment facilities.
