Postal Realty Trust:

The town received a letter from Postal Realty Trust stating that they are monitoring the current administration's comments about privatizing the United States Postal Service as part of the Department of Government Efficiency (DOGE). As the lessor of the local post office, we may be impacted. Staff will keep the board informed on this issue.

Federal Funding Freeze:

The National League of Cities, Colorado Municipal League, and Denver Regional Council of Governments follow the President's Executive Order regarding the federal funding freeze and the subsequent injunction against the action. Our legislators also communicate closely with the town regarding at-risk projects and funding. The staff has made a list of federally funded projects in mid-construction and those awarded but not started in case the situation suddenly changes again. A table of 'at risk' federal funds is attached.

Immigration Enforcement:

Town staff have received communications from the Boulder County Sheriff's Office regarding immigration enforcement and the county's role, as well as from our legislators concerning immigrants' rights, to better prepare for potential visits from ICE or from persons who may show up at town hall or be approached within the town limits. Several handouts are available and posted at town hall to better educate our area residents. Booklets printed in English and Spanish have also been distributed to LEAF.

Old Man Winter Rally partners with local businesses, including La Mariposa, Oskar Blues, Moxie Lyons, Cemex, and the Town of Lyons, along with other regional and national brands.

In 2025, the event had 1,641 registrants, with the 40-mile bike course having the greatest number of participants, with 721 signed up. The Town collects a special event and impact fee, totaling just over \$2,400 this year. In addition, parking revenue on February 2, 2025, was \$1,560. The full report on the event is included in the packet.

January Utility Bills

There were an extra nine days on the January utility bills this month. The town apologizes if this creates a hardship for anyone and should contact us if payment arrangements need to be made. We are actively taking steps to prevent this from occurring in the future. The town recently moved our billing software to the cloud. The new system did not create the proper file required to interact with the meter software on Jan 20th, which it typically does automatically. January 19th was a Sunday, and January 20th was a town holiday. When staff found we did not have the proper file on January 21st, we contacted the metering software company. We knew we had the proper meter reads from the day before, so there was no great concern about extra days on the utility bill. On the 22nd, the meter software company advised there was a problem with a file from the billing software company, and we reached out to work with them. Multiple staff worked back and forth with the two companies to resolve the issue. We did not realize that their final resolution of the issue on the 28th copied over our file from the 20th with the proper meter reads. It was not until the bills went out that this was discovered to try and go back and retrieve a backup of the file from the 20th. The staff has requested that the billing software company update this process to add a date stamp every time a new file is created to prevent the possibility of being overwritten. The February statements will reflect a shorter-than-normal period.

2025 Business License Renewals:

As of today, 71 businesses have been issued local licenses. Approximately 30 known operating businesses have not filed for their 2025 license. This does not include food trucks that may not operate in Lyons until warmer weather. Staff will reach out to the unlicensed businesses and make a request for their applications.

Street Light Survey: The Town of Lyons received a Boulder County Sustainability grant to explore the conversion of town-controlled inefficient streetlights to LED streetlights. The study includes an analysis of the type of lights needed to minimize the effects of light pollution and also helps develop a standard for what street lighting in Lyons could be going forward. We will use community feedback, along with other analyses and safety factors, to provide recommendations for this study. Please provide your input through the link below!

WaterNow Opportunity

On February 13, Town staff submitted an application to WaterNow's Project Accelerator program which aims to help communities jumpstart sustainable water projects. Staff proposed a project that would focus on Green Stormwater Infrastructure (GSI) which would aid in the overall goal of improving stormwater infrastructure in Lyons. If selected, WaterNow would provide technical assistance related to GSI including evaluating Lyons' policies, codes, procedures while also conducting research on best practices, finding case studies, and conducting community outreach. This project could help Lyons' gain an understanding of how GSI could assist with flood resilience and could also empower community members to inspire change at the neighborhood or household level. This is a free program and selection for the program will not occur until late February to March.
