- I. **BACKGROUND:** Oskar Blues would like to modify the licensed premises to add the adjacent driveway to the licensed premises area for four events to be held throughout 2017. Dates are May 5-7, July 1-2, July 28-29 and September 2-4 2017. I have confirmed with the liquor enforcement division that approving several dates is legal/allowed. They have provided information regarding event boundaries and security. Applicant has submitted \$300.00 for the premise modification fee. Public Notices have been posted at the event site and in the local newspaper.
- II. **CRITERIA FOR APPROVAL:** Under the Colorado Code of Regulations, in making its decision with respect to any proposed changes, alterations or modifications, the licensing authority must consider whether the premises, as modified, will meet all pertinent requirements of the Colorado Liquor or Beer Codes and related regulations. Factors to be taken into account by the licensing authority shall include, but not be limited to, the following:
1. The reasonable requirements of the neighborhood and the desires of the adult inhabitants.
  2. The possession, by the licensee, of the changed premises by ownership, lease, rental or other arrangement. Confirmed.
  3. Compliance with the applicable zoning laws of the municipality, city and county or county. Confirmed.
  4. Compliance with the distance prohibition in regard to any public or parochial school or the principal campus of any college, university, or seminary. Waived pursuant to Section 6-2-70 of the Lyons Municipal Code.
  5. The legislative declaration that the Colorado Liquor and Beer Codes are an exercise of the police powers of the state for the protection of the economic and social welfare and the health, peace, and morals of the people of this state.
- III. **FINDINGS:** Staff finds that the application is complete and that the proposed modification complies with applicable law, regulations, and criteria.
