(0.584 acres) of land, more or less, being a portion of that parcel of land described in the Warranty Deed recorded May 11, 1908, in Book 327 at Page 324 and in the Quitclaim Deed recorded December 12, 1991 at Reception Number 1148353, in the Boulder County, Colorado Clerk and Recorder's Office, and being a part of the S.W. 1/4 of the S.W. 1/4 of Section 17 and the S.E. 1/4 of the S.E. 1/4 of Section 18, Township 3 North, Range 70 West, of the 6th Principal Meridian, in Boulder County, Colorado, said Permanent Easement being more particularly described as follows:

COMMENCING at the S.W. corner of said Section 17, whence the W. 1/4 Corner of said Section 17 bears N. 01°03'28"E., a distance of 2605.74 feet; Thence N. 03°03'19" W., a distance of 638.20 feet to a point on the northeasterly line of said parcel and the **POINT OF BEGINNING**;

1. Thence along the northeasterly line of said parcel on the arc of a non-tangent curve to the right, a radius of 1,169.10 feet, a central angle of 01°42'00", a distance of 34.69 feet, (a chord bearing S. 41°28'00" E., a distance of 34.69 feet);
2. Thence continuing along the northeasterly line of said parcel, S. 41°02'48" E., a distance of 355.16 feet;
3. Thence S. 48°48'53" W., a distance of 50.00 feet to a point on the northeasterly line of that parcel of land described in the Warranty Deed recorded July 10, 1894, in Book 163 at Page 237, in the Boulder County, Colorado Clerk and Recorder's Office;
4. Thence along said northeasterly line of Book 163, Page 237, N. 41°02'48" W., a distance of 70.81 feet to the N.E. corner of said Book 163, Page 237;
5. Thence along the north line of said Book 163, Page 237, S. 90°00'00" W., a distance of 32.09 feet;
6. Thence N. 37°37'53" W., a distance of 166.72 feet;
7. Thence N. 45°38'49" W., a distance of 130.18 feet;
8. Thence N. 47°29'46" E., a distance of 74.48 feet, more or less, to the **POINT OF BEGINNING**.

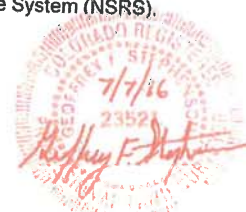

(0.322 acres) of land, more or less, being a portion of that parcel of land described in the Warranty Deed recorded May 11, 1908, in Book 327 at Page 324 and in the Quitclaim Deed recorded December 12, 1991 at Reception Number 1148353, in the Boulder County, Colorado Clerk and Recorder's Office, and being a part of the S.W. 1/4 of the S.W. 1/4 of Section 17 and the S.E. 1/4 of the S.E. 1/4 of Section 18, Township 3 North, Range 70 West, of the 6th Principal Meridian, in Boulder County, Colorado, said Temporary Easement being more particularly described as follows:

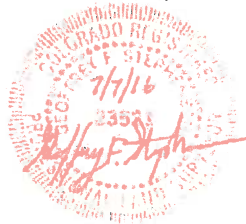
