RESOLUTION 2017-61**

**A RESOLUTION APPROVING AN INTERGOVERNMENTAL COOPERATIVE AGREEMENT  
WITH BOULDER COUNTY AND THE BOULDER COUNTY SHERIFF'S OFFICE FOR  
FUNDING A HALF-TIME CREW BOSS POSITION FOR SUPERVISING TOWN  
MAINTENANCE PROJECTS**

**WHEREAS**, the Town of Lyons (the "Town") has the authority to enter into contracts for any lawful municipal purpose pursuant to C.R.S. § 31-15-101; and

**WHEREAS**, local governments, including statutory towns, are authorized by C.R.S. § 29-1-201 *et seq.* to enter into intergovernmental agreements with other local governments to provide any function, service, or facility lawfully authorized to each of the cooperating or contracting units; and

**WHEREAS**, the Town requires the assistance of the Boulder County Sheriff's Office ("Sheriff's Office") to provide Jail Inmate Work Crews ("Work Crews") for cleaning and maintenance of Town properties; and

**WHEREAS**, Work Crews need to be supervised by Sheriff's Office Crew Bosses ("Crew Bosses"); and

**WHEREAS**, the Town's needs for Work Crews exceed the County's and Sheriff's Office's number of available Crew Bosses; and

**WHEREAS**, an additional half-time Crew Boss position in the Sheriff's Office to oversee additional Work Crews would meet the Town's needs to provide cleaning and maintenance of Town properties; and

**WHEREAS**, the interests of the public are best served by the Town funding a dedicated half-time Crew Boss position in the Sheriff's Office to oversee Work Crews on Town cleaning and maintenance projects; and

**WHEREAS**, Boulder County has prepared an Intergovernmental Cooperative Agreement between Boulder County, the Boulder County Sheriff's Office, and the Town, which agreement specifies the funding that the Town shall be required to provide in exchange for services to be provided by the Work Crew oversight by a dedicated half-time Crew Boss position in the Sheriff's Office (the "Agreement"); and

**WHEREAS**, the Board of Trustees desires to approve the Agreement, and further desires to authorize the Mayor or Mayor Pro Tem and the Town Administrator to execute the Agreement.

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE TOWN OF LYONS, COLORADO:**

Section 1. The Board of Trustees hereby (1) approves Intergovernmental Cooperative Agreement between Boulder County, the Boulder County Sheriff's Office, and the Town in the form substantially attached hereto as **Exhibit "A"**; (2) authorizes the Town Administrator, in consultation with the Town Attorney, to make such changes to the Intergovernmental Cooperative Agreement as may be required to the extent they do not materially increase the obligations of the Town; (3) authorizes the Mayor or Mayor Pro Tem and the Town Administrator

to execute such Agreement; and (4) authorizes Town staff to take all actions necessary to implement the Agreement.

Section 2. This resolution shall become effective immediately upon adoption by the Board of Trustees.
