RESOLUTION 2020-45**

**A RESOLUTION OF THE TOWN OF LYONS APPROVING THE 2020 THIRD RENEWAL AND  
AMENDMENT TO INTERGOVERNMENTAL COOPERATIVE AGREEMENT WITH BOULDER  
COUNTY AND THE BOULDER COUNTY SHERIFF'S OFFICE FOR FUNDING A HALF-TIME  
CREW BOSS POSITION FOR SUPERVISING TOWN MAINTENANCE PROJECTS**

**WHEREAS**, the Town of Lyons (the "Town") has the authority to enter into contracts for any lawful municipal purpose pursuant to C.R.S. § 31-15-101; and

**WHEREAS**, local governments, including statutory towns, are authorized by C.R.S. § 29-1-201 *et seq.* to enter into intergovernmental agreements with other local governments to provide any function, service, or facility lawfully authorized to each of the cooperating or contracting units; and

**WHEREAS**, the Town previously entered into that certain Intergovernmental Cooperative Agreement, dated June 6, 2017, with the County of Boulder ("County") and the Boulder County Sheriff's Office ("Sheriff's Office") for the provision of jail inmate work crews ("Work Crews") supervised by a Sheriff's Office crew boss ("Crew Boss") to assist with the cleaning and maintenance of Town properties ("IGA"); and

**WHEREAS**, the Work Crews and Crew Boss provided by the Sheriff's Office allow the Town to better service the community by permitting regular staff to complete a backlog of higher priority projects; and

**WHEREAS**, through the IGA, the Town funded a half-time Crew Boss position in the Sheriff's Office in order to receive the services provided by the Work Crew and Crew Boss; and

**WHEREAS**, the IGA was renewed in 2019 by the County and the Town through the 2019 Second Renewal and Amendment ("Second Renewal");

**WHEREAS**, Paragraph 11 of the First Renewal to the Original IGA provides for the renewal of the IGA in writing within ninety (90) days of December 31, 2019; and

**WHEREAS**, Boulder County has prepared the 2020 Third Renewal and Amendment to Intergovernmental Cooperative Agreement between Boulder County, the Boulder County Sheriff's Office, and the Town ("Third Amendment"), attached hereto as **Exhibit 1**; and

**WHEREAS**, the Amendment provides that the Town will fund a dedicated half-time Crew Boss position in the Sheriff's Office during the term of the Second Amendment for an amount not to exceed **Eighteen Thousand Dollars and No Cents (\$18,000.00)**; and

**WHEREAS**, the Board of Trustees desires to approve the Third Amendment in substantially the form attached hereto, and further desires to authorize the Mayor or Mayor Pro Tem and the Town Administrator to execute the Third Amendment.

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE TOWN OF LYONS, COLORADO:**

Section 1. The above recitals are hereby incorporated by reference.

Section 2. The Board of Trustees hereby:

(1) Approves the 2020 Third Renewal and Amendment to Intergovernmental Cooperative Agreement between Boulder County, the Boulder County Sheriff's Office, and the Town in substantially the form attached hereto as **Exhibit 1**;

(2) Authorizes the Town Administrator, in consultation with the Town Attorney, to negotiate and make such changes to the Third Amendment as may be required to the extent they do not materially increase the obligations of the Town;

(3) Authorizes the Mayor or Mayor Pro Tem and the Town Administrator to execute such Third Amendment; and

(4) Authorizes Town staff to take all actions necessary to implement the Third Amendment.

Section 3. This resolution shall become effective immediately upon adoption by the Board of Trustees.
