

2020 THIRD RENEWAL TO
INTERGOVERNMENTAL COOPERATIVE AGREEMENT

This Third Renewal is to the Intergovernmental Cooperative Agreement dated June 6, 2017 (the “IGA”), between the County of Boulder, by and through its Board of County Commissioners (“County”), the Boulder County Sheriff’s Office (“Sheriff’s Office”), and the Town of Lyons, Colorado (“Town”) (collectively the “Parties”).

Recitals:

- A. The Parties entered into the IGA dated June 6, 2017, by which the Sheriff’s Office agreed to provide Jail Inmate Work Crews (“Work Crews”) to the Town for cleaning and maintenance of town properties for 6 months from June 1, 2017 to December 31, 2017.
- B. Under the IGA, the Town agreed to provide the Sheriff \$18,000 to fund a dedicated half-time (.5) Sheriff’s Office Crew Boss position (“Crew Boss”) to oversee the additional Work Crews needed to meet the Town’s needs.
- C. On January 1, 2018, the Parties renewed the IGA for an additional 12 months and amended the IGA to provide the Town with more flexibility to schedule the Crew Boss and Work Crew for work throughout the fiscal year.
- D. On January 1, 2019, the Parties renewed the IGA for a second time, for an additional 12 months.
- E. The Parties wish to renew the IGA for an additional (12) months beginning January 1, 2020 and ending December 31, 2020 in accordance with paragraph 11 of the IGA.

Now, therefore, the County, the Sheriff’s Office, and the Town hereby agrees as follows:

1. Upon execution of this Third Renewal (“Renewal”) and in accordance with Paragraph 10 of the IGA, the Town shall provide \$18,000.00 to the Sheriff’s Office to fund a half-time (.5) Crew Boss dedicated for Town use throughout a term of twelve (12) months beginning January 1, 2020 and ending December 31, 2020, with work to be scheduled for no more than 26 weeks out of the 52 weeks available during the term.
2. The Town commits to funding this half-time County position for 2020 in an amount not to exceed \$18,000.00. The Town agrees it is limited to scheduling the Crew Boss and Work Crew for work for no more than 26 weeks out of the 52 weeks available during the 12 month term.

3. The Renewal shall be incorporated into the terms of the original IGA, dated June 6, 2017.
4. Except as may be amended herein the terms and provisions of the original IGA, and any subsequent amendments to the original IGA, shall remain in full force and effect.
5. This Amendment shall be incorporated into the terms of the original IGA, dated June 6, 2017.
6. Except as may be amended herein the terms and provisions of the original IGA, and any subsequent amendments to the original IGA, shall remain in full force and effect.
