## A RESOLUTION OF THE TOWN OF LYONS, COLORADO RATIFYING AND APPROVING SENDING A LETTER OF INTENT TO PARTICIPATE IN THE 2021-2026 BOULDER COUNTY HAZARD MITIGATION PLAN TO BOULDER COUNTY

- **WHEREAS**, the Town of Lyons ("Town") is a statutory municipality organized under the laws of the State of Colorado; and
- **WHEREAS**, pursuant to C.R.S. § 30-15-401 *et seq.*, the Town is authorized to enter into contracts with other governmental organizations for mutual benefit; and
- **WHEREAS**, the Town and Boulder County, Colorado ("Boulder County") (collectively the Parties") desire to collaborate on a multi-jurisdictional mitigation plan for Federal Emergency Management Agency's ("FEMA") Local Hazard Mitigation Plan ("HMP"); and
- **WHEREAS**, Boulder County requested the Town submit a "Letter of Intent to Participate" in the 2021-2026 Boulder County HMP;
- **WHEREAS**, response was required to Boulder County before a resolution could be prepared with public notice; and
- **WHEREAS**, it was in the interest of the public health, safety, and welfare of the Town to respond as quickly as possible to Boulder County; and
- **WHEREAS**, at its May 3, 2021 meeting the Board of Trustees (the "Board) voted to authorize the Mayor to provide Boulder County with a Letter of Intent to Participate on behalf of the Town; and
- **WHEREAS**, on May 4, 2021, the Mayor provided a Letter of Intent to Participate to Boulder County, attached hereto as **Exhibit A** and incorporated by reference, consistent with the Board's authorization; and
- **WHEREAS**; the Board wishes to approve this Resolution to ratify the Board's decision on May 3, 2020 to authorize a the Mayor to send a letter of intent to Boulder County to participate in the HMP program.

## NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE TOWN OF LYONS, COLORADO:

- <u>Section 1.</u> The above recitals are hereby incorporated by reference.
- <u>Section 2.</u> The Town Board of Trustees hereby:
  - a) Ratifies and approves its May 3, 2020 decision to authorize the Mayor to provide Boulder County with a Letter of Intent to Participate in the HMP on behalf of the Town.

- b) Ratifies and approves the Letter of Intent to Participate attached as **Exhibit A**.
- <u>Section 3.</u> This Resolution shall take effect immediately upon adoption.
