**I. REQUEST OR ISSUE:**

This resolution ratifies the First Amendment with Murraysmith, Inc. for Design Services for the 4<sup>th</sup> Ave Pedestrian Bridge Design Project.

**II. RECOMMENDED ACTION / NEXT STEP:**

Approve Resolution 2021-59.

**III. FISCAL IMPACTS:**

Expenses for this Professional Services Contract are eligible for reimbursement through the Department of Housing and Urban Development Community Development Block Grant Disaster Recovery (“CBDG-DR”) administered by the Boulder County Collaborative under the Intergovernmental Agreement between the Town of Lyons and the City of Longmont. A grant from Safe Routes to School will be funding construction for the project.

**IV. BACKGROUND INFORMATION:**

**4th Ave Pedestrian Bridge, Trail Connections, and Street Improvements Project Scope:**

The conceptual improvements connecting the pedestrian bridge include regrading and adding sidewalk improvements on the east and west side of 4th Avenue from Evans Street to High Street, including installation of new sidewalk, driveways, and curb cuts. 4th Avenue crosses the Colorado Department of Transportation (CDOT) right-of-way along US-36 and may require coordination and approvals.

**About This Amendment:**

The contractor required additional time to complete their scope of work due to an adapted project timeline.

This amendment was executed by the Town Administrator on June 14, 2021, as authorized by the Town Purchasing Policy. The Town's Purchasing Policy allows the Town Administrator to execute professional service agreements that incur less than or equal to a \$10,000 increase to the contract price and/or for term extensions.
