**I. REQUEST OR ISSUE:**

This resolution would amend section 10 of the original IGA for transportation services with Boulder County for an amount of up to \$80,000.

**II. RECOMMENDED ACTION / NEXT STEP:**

Support the amended IGA with Boulder County in order to provide greater financing for transportation services for Lyons residents.

**III. FISCAL IMPACTS:**

Boulder County would upgrade their support of zTrip Transportation Services for Lyons residents from \$40,000 (original) to \$80,000 with the amended IGA.

**IV. BACKGROUND INFORMATION:**

Boulder County has asked the Town of Lyons to accept this amended IGA for an additional \$40,000 of Boulder County funding and support for Transportation Services. This alternative transportation service is provided in lieu of not having current RTD regional Y bus service in Lyons due to COVID.

Boulder County continues to work with RTD to return bus service from Lyons to Boulder. However, at this time they both are uncertain as to whether the service will return in September 2021 or not until January 2022.

By authorizing the amendment, Boulder County will have Lyons support to continue to

work with RTD to execute a cost-sharing agreement with the Regional Transportation District for the reimbursement of fifty percent (50%) of the direct costs of operating the taxi voucher program, with requirements acceptable to all Parties, then Boulder County shall pay to Lyons an amount up to eighty thousand dollars (\$80,000).

**V. LEGAL ISSUES:**

**VI. CONFLICTS OR ENVIRONMENTAL ISSUES:**

**VII. SUMMARY AND ALTERNATIVES:**

Boulder County and Town of Lyons staff recommend approval of the resolution. However, the Board may also choose to not approve the resolution.
