This AMENDMENT (“Amendment”) to the above-referenced Contract (“Contract”) is entered into by and between the Board of County Commissioners on behalf of the County of Boulder, State of Colorado, a body corporate and politic, for the benefit of the Community Planning & Permitting (“County”) and Town of Lyons (“Contractor”).

1. INCORPORATION OF AMENDMENT SUMMARY

The **Amendment Summary** is incorporated into this Amendment. The **Additional Contract Documents**, if any are listed, are incorporated into this Contract by reference.

2. EFFECTIVE DATE AND ENFORCEABILITY

This Amendment shall not be effective or enforceable until it is approved and signed by both Parties. Upon mutual execution hereof, the Parties agree that this Amendment shall be effective commencing on the **Amendment Effective Date** set forth above.

3. LIMITS OF EFFECT

This Amendment is incorporated by reference into the Contract. The Contract, and all prior amendments thereto, if any, shall remain in full force and effect except as specifically modified herein.

4. MODIFICATIONS

The Contract and all prior amendments thereto, if any, are modified as follows:


c. Amount. The price of the Contract is amended to include additional funds not-to-exceed the **Additional Amount** for the current **Contract Term**.

d. Section 10 of the IGA is hereby deleted and replaced with the following:

In consideration of the services provided by Lyons under this Agreement, and the mutual financial commitments herein made, Boulder County agrees to contribute to the direct costs of operating the taxi voucher program. For the Term of this Agreement, Boulder County shall pay to Lyons an amount up to forty thousand dollars (\$40,000) for the value of eligible redeemed taxi vouchers for the year 2021. If during the Term of this Agreement Boulder County is able to execute a cost-sharing agreement with the Regional Transportation District for the reimbursement of fifty percent (50%) of the direct costs of operating the taxi voucher program, with requirements acceptable to all Parties, then Boulder County shall pay to Lyons an amount up to eighty thousand dollars (\$80,000). Lyons shall invoice Boulder County monthly for the value of all vouchers redeemed in the previous calendar month. Each invoice shall include a list of each voucher amount redeemed. Payment to Lyons shall be made within 60 days after receipt of an invoice. In no event shall Boulder Count contribute an amount greater than the total direct operating costs for the year 2021.
