**A RESOLUTION OF THE TOWN OF LYONS, COLORADO CANCELLING
THE APRIL 5, 2022, TOWN OF LYONS REGULAR MUNICIPAL ELECTION
AND DECLARING THE CANDIDATES FOR THE OFFICES OF MAYOR
AND TRUSTEE ELECTED**

WHEREAS, the Town Clerk has been duly authorized by the Board of Trustees to cancel and declare candidates elected at the close of business on the sixty-fourth day before the election to be conducted on April 5, 2022; and

WHEREAS, the Board of Trustees for the Town of Lyons (the "Board") consists of one (1) Mayor and six (6) Trustees; and

WHEREAS, an election has been scheduled for April 5, 2022, to fill the Mayoral seat and six (6) Trustee seats; and

WHEREAS, the deadline for filing Nomination Petitions was January 24, 2022.

WHEREAS, only one (1) candidate for Mayor submitted the appropriate petition to be included on the April 5, 2022, ballot (the "Ballot"), which petition has been found to be in substantial compliance with the Colorado Municipal Election Code; and

WHEREAS, only six (6) candidates for Trustee submitted the appropriate petitions and paperwork to be included on the Ballot, which petitions have been found to be in substantial compliance with the Colorado Municipal Election Code; and

WHEREAS, the deadline for filing Affidavits of Intent for write-in candidates was January 31, 2022; and

WHEREAS, no qualified individual has submitted an Affidavit of Intent to be a write-in candidate on the Ballot; and

WHEREAS, it is provided by Ordinance 997 and pursuant to C.R.S. § 31-10-507 that the Board can instruct the Town Clerk by resolution to cancel an election and declare the candidates elected when the only matter before the voters is the election of persons to office and, if at the close of business on the deadline for filing Affidavits of Intent for write-in candidates, there are not more candidates than offices to be filled at such election; and

WHEREAS, the Board desires to cancel the April 5, 2022 election.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE TOWN OF LYONS, COLORADO, AS FOLLOWS:

Section 1. The Town Clerk is hereby directed to cancel the April 5, 2022, regular municipal election for the Town of Lyons.

Section 2. The following individuals are hereby declared elected to the respective offices for the terms indicated:
