- 58 1. Flood Recovery Update – Manager Sanders updated on Ped Bridge, ramps and sidewalks
59 and prepping for abutments. Black Bear Hole, delay due to lots of erosion, will do irrigation,
60 landscaping and improvements to parking lot. Bohn Park fields drainage issue, they have
61 been working on it the last two weeks, meet tomorrow to reassess.
62 2. Administrator’s Report – Emergency sirens start being tested April-Oct. will do a silent test in
63 April; Comp plan – open house April 12th 6:30 to 8pm. Building permits on the rise;
64 congressional spending now open, accepting applications, have 4 projects we would like to
65 submit a letter of support. MPT Browning, generally have concerns, would like update on
66 WWTP. This board added to the 22 budget for wildfire mitigation. Where are we with Martin
67 Parcel? Consensus is to send in letter of support. Administrator Simonsen, wildfire
68 proposal from ad hoc committee for short/long term goals, funding, etc. meeting tomorrow
69 then with Fire then to new board. Fire department wants to be involved.
70 3. Legal Update – Attorney Dittman updated on Honeywell. Trustee Lowell, on Yoder matter,
71 your firm charged \$1700, one hearing hired a hearing officer, any costs recoverable?
72 Attorney Dittman, potentially, courts don’t like to assign attorneys fees to defendants.
73 Trustee Lowell, last week quite a bit of activity around the Yoder house, has building permit
74 been pulled? Administrator Simonsen, only to finish siding, bank rep. and contractor on
75 sight several times.

83 liquor license, modeled after original shop in Louisville. Not anticipating a rowdy endeavor;
84 we have a good track record, responsible, community driven. **No public comments.**

87 2. New Hotel & Restaurant Liquor License - Marigold Lyons, LLC at 405 Main Street – Deputy
88 Clerk Davis presented. Applicant Theo Adley, 4428 Greenbriar Blvd, Boulder, long running
89 love of Lyons, feeling blessed and lucky to be here. Thanked staff for their help. Kelly
90 Whitaker, 3060 Apollo Park Way, Boulder, in support, is successful wherever he goes.
91 Cristy Hoffman, 2024 Apple Valley, in full support, excellent chef, wonderful for the town.
92 Andy Clark, 140 Walnut, whole heartedly support him, exciting things on Main Street, look
93 forward to your restaurant opening. MPT Browning asked if building is leased, Theo
94 confirmed it is owned. MPT Browning asked if there would be outdoor seating? Clerk Davis,
95 this application is for indoor dining only. They would need to come before the board again if
96 they wish to modify the premises **Motion:** Move to approve **Moved by:** MPT Browning
97 **Seconded by:** Trustee Waugh **motion passes 7-0**

100 X. Public Hearings and Ordinances

- 101 1. 2ND Reading – Public Hearing - Ordinance 1118 – an Ordinance of the Town of Lyons,
102 Colorado Amending an Annexation Agreement with Planet Bluegrass Farm, LLC for the
103 Planet Bluegrass Farm Property – Planner Strom presented. Dept. of Parks, Fish & Wildlife
104 requested more information on Prebble’s mouse, prior conditional use approval will not
105 override what Fish & Wildlife require. Utility requirements are updated in agreement.
106 Trustee Rogin if Fish & Wildlife has final approval how can we approve? Attorney Dittman,
107 parallel requirements, land use, and endangered species. That is a separate parallel track,
108 we have no authority over that. Trustee Rogin, what happens if we approve, and they say
109 no? Attorney Dittman, only a portion of property affected, but they could not operate.
110 Trustee Lowell, a lot of conditions from Fish and Wildlife; need habitat assessment,
111 reorganizing layout, appropriate for us to put caveat on approval depending on Fish and
112 Wildlife? Attorney Dittman, hard to separate the properties that are affected. Fish and
113 wildlife have final say; would have to come back for modification for these land use
114

115 approvals. Mayor Angelo, interesting that a taking could occur, mitigating circumstances.
116 Have concern without letter of concurrence. Since mid-tier events allow 3K participants,
117 there will be no camping? Planner Strom, correct, only for large events. Zach Tucker, 1804
118 Tyler Ave, Longmont, thanked subcommittee and staff, very productive. Committed to all we
119 agreed on. MPT Browning, will the Planet commit to sharing/keeping town up to date on
120 Fish & Wildlife status. Zach, that is very reasonable. **Public Hearing opened at 8:29 pm.**
121 Andy Clark, 140 Walnut, Louisville, voice support for Planet, they helped put Lyons on the
122 map, provides jobs, builds community, creates commerce. **Public hearing closed at 8:31**
123 **Motion:** move to approve **Moved by:** MPT Browning **Seconded by:** Trustee Karavas MPT
124 subcommittee tackled the big items, not easy to work through. In favor of this, PB has been
125 very reasonable and responsive to concerns of AV residents. Hope PB/next board/staff
126 discuss municipal impact fee, lodging tax. Mayor Angelo, world class facility, but I take issue
127 with comments dismissing concern of an endangered species. I will support this. **Motion**
128 **passes 7-0**

179 friend of mine, I served with her mother Frances Backet, pioneer family. Couldn't think of a
180 more appropriate thing to do. **Motion:** move to approve **Moved by:** MPT Browning
181 **Seconded by:** Trustee Karavas **Motion passes 7-0**
- 182 2. Resolution 2022-39 A Resolution of the Town of Lyons, Colorado Dedicating the Trail Along

184 move to approve **Moved by:** MPT Browning **Seconded by:** Trustee Rogin MPT many know
185 her as a very valuable town employee. All the work she did during the flood was not paid,
186 she put in countless hours. Trustee Lowell, I never saw her get tired. I wish we could
187 dedicate more to her, but a great way to honor her. Trustee Karavas she took a beating
188 sometimes and never shied away; upwards of 1,000+ hours a year, very well deserved.
189 Trustee Rogin echoed and last couple of years remarkably tough, she looks out for the
190 town. The least we could do. Trustee Miller, she is a powerhouse. Mayor Angelo, always so
191 positive; loves the town. **Motion passes 7-0**

- 201 5. Resolution 2022-36 – a Resolution of the Town of Lyons, Colorado Approving a
202 Development Agreement with Moss Rock Development, LLC - Planner Strom presented;
203 Trustee Rogin asked why number of parking spaces on 2nd Ave lot reduced? Attorney
204 Dittman negotiated 70 spaces; thought 30 was most the town could give. Administrator
205 Simonsen, they don't have a big interest in using that lot (8 spaces) a shuttle isn't much
206 interest to them. New layout, 2 full sides of parking lot, felt sufficient for their needs. MPT
207 have rates been set for that lot? Discussed low-cost spaces. Administrator Simonsen,
208 hoping to keep those closest to Black Bear hole and encourage bicyclists to park there, a
209 combination of rates. Attorney Dittman, last minute request from applicant in section A
210 regarding Branding, would like word Un-branded removed, not a chain, but would like to
211 brand. **Motion:** move to approve **Moved by:** MPT Browning **Seconded by:** Trustee Waugh
212 **Motion:** amendment to section 2.11 regarding fire, add "developer will create in conjunction
213 with Lyons Fire a wildfire evacuation plan **Moved by:** Trustee Rogin **Seconded by:** MPT
214 Browning **Amendment passes 7-0** **Motion:** amend recital section paragraph to remove
215 unbranded **Moved by:** MPT Browning **Seconded by:** Trustee Lowell **Amendment passes**
216 **7-0 Resolution as amended passes 7-0**
- 217 6. Resolution 2022-37 – a Resolution of the Town of Lyons, Colorado Amending the 2022
218 Budget – Finance Director Eyestone presented on different options. MPT Browning if
219 additional funds come available, we could replenish these funds? Director Eyestone
220 confirms, we would reappropriate then. MPT Browning does the board need to identify
221 which funds get replenished first? Director Eyestone, the board should give guidance. Mayor
222 Angelo, what is causing all these projects to come in over what we projected? Director
223 Sanders, rise in design and admin costs. CDOT funding also requires a lot of
224 documentation, construction/engineering costs way up. Mayor Angelo, my concern is we are
225 in an inflationary spiral, I think we'll see even higher costs, hopefully we can offset with

226 additional funding sources. Director Sanders, we add a 10% contingency to all projects for
227 that reason. Trustee Rogin, what is end date for potential claw backs? Manager Sanders,
228 one for ineligible costs about 1 million we have covered with set aside. State is about 1%.
229 Claw back is when OIG audits FEMA and State not the Town. That timeline depends on
230 when entire disaster is closed, then 3 years after that. **Motion:** move to approve **Moved by:**
231 **MPT Browning** **Seconded by:** Trustee Waugh **Motion:** amendment to add in section 2 last
232 sentence, to the extent funds from additional sources are received, it is recommended that
233 such additional funds be used to replenish these funds in order : 1. Claw backs,
234 Conservation, and Parks **Moved by:** MPT Browning **Seconded by:** Trustee Karavas
235 **amendment passes 7-0** MPT Browning commended staff, I too didn't want to take funds
236 away from streets, flood claw back is an unknown. **Resolution as amended passes 7-0**
237 7. Agenda Request – Use of Marquee for Lyons Film Festival – Administrator Simonsen Jackie
238 Brennan, Evans St, submitted request. Town policy does not allow except for town events.
239 Board can waive; staff has no issue. We have comp plan open house posted, leave that up
240 till 4/13. Trustee Rogin, huge film festival fan, but a policy is in place, best to deny this
241 request until we can get a policy in place. MPT Browning, I agree with that. Trustee Lowell
242 go ahead and use it. **Consensus is to deny request.**
