Tsitsistas ("tsi-tsi-stahs")/Cheyenne


Nuuchi-u ("new-chew") Ute

We respect the native plants and strive to help them thrive.




We respect the animals who co-exist with us.

May we understand our history in our efforts to heal the traumas of the past and present and to activate steps to manifest reparations now and into the future.


- Audience Business
- Staff Report
 - 1st reading of the preservation ordinance for the Depot took place on Mon., 8/19
 - 2nd reading will take place on September 3rd, then the 30 day waiting period begins. It would be great if HPC members could plan on attending, but it will be a late meeting (reading likely won't happen until 9pm or later).
 - Met with representatives of the Arapaho tribes (WY) and discussed finding opportunities for children of the tribe to visit Lyons (related to trail maker)
- Old Business
 - EV Charging Station at Old Depot Loading Dock (at Sandstone)
 - BOT Update - The BOT voted to install the EV charging station on the eastern end of Sandstone Park, leaving the loading ramp untouched.
 - *Potential Future Project - Create some sort of signage for the ramp to explain its prior use and history.*

 - The Historic Preservation Commission (HPC) discussed and approved the allocation of its 2024 budget, amounting to \$1,000. The Commission agreed to hire a representative from local Native American tribes through a contract consulting agreement. This individual will provide expertise and guidance on ways to honor and preserve Native American heritage within the community. Specific opportunities include consultations on a trail marker at Lavern Johnson Park and a new exhibit at the Redstone Museum, both planned for 2025.
 - For 2025, the HPC voted to request a budget of \$2,000. These funds will support community engagement initiatives in collaboration with local Native American tribes, including the Arapaho, Ute, and Cheyenne. Planned events include a ceremonial dedication for the trail marker at Lavern Johnson Park and the unveiling of Native American artifacts at the Redstone Museum. The Commission intends to hire local tribes to provide traditional dance and music, enriching the events with authentic cultural



expressions. A portion of these funds will also support the rollout of the local historic designation program and the completion of the Historic Context Survey Grant, expected by April 2025.



4) Land Acknowledgement - Lack of Actionable Goals


- Engage with Tribal Representatives for Guidance (Chelsea/Mia might be able to assist with this.)

- The consensus of the HPC was that we should not be using the language, "Good Old Days", and are requesting that the BOT direct staff to remove that language from Town materials. While the HPC finds it important to celebrate Lyons' history, we must still consider the broader context and consider all perspectives.



2024 Budget

- Request #1 Description: Certified Local Government (CLG) Subgrant: Historic Context Survey, Local Match Requirement (5.67% of Grant); Deadline for completion of Historic Context Survey is April 1, 2025.
 - Amount \$1500.00



- Request #2 Description: Funds to design and create bronze plaques for property owners who choose to designate their property as a Historic Property, recognized by the Town of Lyons and State of Colorado. The plaques would be displayed on the exterior of the property, identifying it as a Local Landmark. The City of Longmont issues a plaque like the one below. Rough cost estimates are \$125 p/plaque; the requested budget is for 5 properties to be designated in 2024.
 - Amount \$625.00
- Request #3 Description: Funds to organize and host 2-3 porch talks in 2024. Topics would likely focus on historic properties (to support the HPC's work in rolling out our Historic Designation Program) and/or the History of Lyons (to support the HPC's work on the Historic Context Survey Grant).
