**RESOLUTION OF THE TOWN OF LYONS, COLORADO ADOPTING A GRANT POLICY USING
CORONAVIRUS AID, RELIEF, AND ECONOMIC SECURITY ("CARES") ACT FUNDING**

WHEREAS, the Town of Lyons expects to receive approximately \$92,000 in Coronavirus Aid, Relief, and Economic Security ("CARES") Act funding; and

WHEREAS, the Town of Lyons has incurred direct expenses related to COVID of approximately \$42,000; and

WHEREAS, after reimbursing its direct town related COVID expenses, the Town of Lyons desires to help local non-profit organizations with their COVID-19 response efforts.; and

WHEREAS, Town staff has reached out to both the Lyons Emergency Assistance Fund ("LEAF") and the Lyons Community Foundation ("LCF"); and

WHEREAS, these local Lyons area non-profits are best able to distribute the CARES funds directly to the community; and

WHEREAS, both LEAF and LCF are willing to help distribute the funds; and

WHEREAS, the funds will be used to help those in Lyons most impacted by COVID-19; and

WHEREAS, the maximum potential amount to assist and disburse is \$50,000; and

WHEREAS, the local non-profits have an established application process to verify both local residents and local businesses who are most in need of CARES Act funding; and

WHEREAS, the funds must be fully distributed before December 30, 2020; and

WHEREAS, the Board of Trustees of the Town of Lyons ("Board") supports the disbursement of additional CARES Act funds via this process.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE TOWN OF LYONS, COLORADO:

Section 1. The Board of Trustees supports and approves the disbursement of a maximum \$50,000 in CARES funds to LEAF.

Section 2. The Board of Trustees authorizes the Town Administrator to execute any and all documents required ensure the funds are distributed appropriately.

Section 3. This resolution shall become effective immediately upon adoption.



 INFORMATION

- I. **REQUEST OR ISSUE:** This resolution would authorize a grant policy that would allow the town to assist local non-profit organizations with COVID-19 related expenses.
- II. **RECOMMENDED ACTION / NEXT STEP:** Adoption of Resolution 2020-153.
- III. **FISCAL IMPACTS:** This would not have a direct fiscal impact on the Town of Lyons budget. This resolution would be funded through approximately \$50,000 of Coronavirus Aid, Relief and Economic Security (CARES) Act funding.
- IV. **BACKGROUND INFORMATION:** The town is anticipated to receive approximately \$92,000 through CARES Act Funding that is being distributed through Boulder County. These funds must be used specifically for allowable items and must be spent prior to December 30, 2020. The town is anticipating incurring direct expenses of \$42,000. The remaining funds would be distributed through LEAF and would go toward individual needs due to the COVID crisis and to business related expenses that would be administered by Lyons Community Foundation.
- IV. **LEGAL ISSUES:** None known.
- VI. **CONFLICTS OR ENVIRONMENTAL ISSUES:** None known.
- VII. **SUMMARY AND ALTERNATIVES:** The Board could choose to pass the resolution as presented, or change the allocations as they see appropriate.
