RESOLUTION 2021-05**

**A RESOLUTION OF THE TOWN OF LYONS, COLORADO ACCEPTING PUBLIC
IMPROVEMENTS OF THE ST VRAIN CREEK RECOVERY PROJECT**

WHEREAS, the Town of Lyons determined to restore and stabilize approximately 350 linear feet of the St. Vrain Creek corridor south of McConnell Drive, including debris removal, slope stabilization, bank protection, boulder and rip rap installation, and revegetation during the flood as part of Flood Recovery ("Project"); and

WHEREAS, the Town obtained funding for the St Vrain Creek Recovery Project through the Department of Housing and Urban Development Community Development Block Grant Disaster Recovery ("CBDG-DR") administered by the Boulder County Collaborative under the Intergovernmental Agreement between the Town of Lyons and the City of Longmont, Sub-allocation INF-00066; and

WHEREAS, all construction work for the project by Na Ali'i Consulting and Sales, LLC ("Construction Contractor") is complete and has been inspected by Anderson Consulting Engineers ("Design Engineer") and the Public Works Department, and has been found to be acceptable and in accordance with the plans and specifications; and

WHEREAS, a Certificate of Substantial Completion was executed on October 14, 2020 as shown in **Exhibit 1**; and

WHEREAS, the Design Engineer has submitted a Recommendation of Acceptance dated November 23, 2020 as shown in **Exhibit 2**; and

WHEREAS, Staff has received the record drawings from the Contractor, which reflect how the project was built, as well as lien releases for the improvements constructed; and

WHEREAS, Staff recommends accepting the St. Vrain Creek Recovery Project improvements;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE TOWN OF LYONS, COLORADO:


Section 1. The above recitals are hereby incorporated by reference.



Per the work agreed to in the Construction Agreement between the Town of Lyons and Na Ali'i Consulting & Sales, LLC (the "Contractor"), executed April 1st, 2020, please see the attached Certificate of Substantial Completion. This letter serves as the Certificate for Final Completion for the Town of Lyons Saint Vrain Creek Recovery Project.

Na Ali'i has completed the work in general conformance with the contract documents. The contractor has provided as-built survey of the site, demonstrating general conformance with the grading plan. All the work has been tested, inspected, and is found to be acceptable. Possible exceptions are listed in the attached punchlist.

It is our recommendation that the Board of Trustees accept the public infrastructure installed as noted with a warranty period beginning on October 14, 2020, hence expiring at the end of the day on October 14, 2022.
