Lyons Wildfire Rebate Program Application

In 2025 the Town of Lyons will be offering limited rebates to homeowners in the town limits of Lyons who complete wildfire mitigation efforts approved by Boulder County and Wildfire Partners. This Town rebate program is offered in addition to the Boulder County Wildfire Partner's Rebate Program, but there are a few steps you must complete prior to seeking the Lyons rebate.

How to Qualify:

- In order to receive a Town of Lyons rebate you must:
 1. Complete a Wildfire Partners Individual Home Assessment (<https://wildfirepartners.org/rebate>)
 - i. Complete the Home Assessment as soon as you can to be eligible for the Lyons rebate program.
 - ii. Note that the Home Assessment is NOT required for the Wildfire Partners Rebate program. You are eligible to receive the Wildfire Partners rebate without a home assessment but must follow their application and mitigation requirements.
 2. Complete Wildfire Partners Approved Wildfire Mitigation Activities for the current year
 3. Fulfill all requirements for the Wildfire Partners Rebate Program AND receive or have a pending rebate
 - i. Boulder County will be verifying the information and sharing information with Lyons which is why you must be involved in their program prior to receiving a Lyons rebate.
 4. Submit a Town of Lyons Rebate Application (this form) upon completion of your wildfire mitigation.

Frequently Asked Questions:

- Will work completed prior to the program be eligible?
 - Work completed prior to the release of the program will NOT be eligible for a rebate. All eligible work must be completed after the release of the program and approved by Wildfire Partners.
- Can I use a Wildfire Partners Home Assessment from a year other than 2025?
 - Yes! The Wildfire Partners Home Assessment may be from another year as long as it is for the current home owner/applicant. If the house is sold the assessment may not be used from a previous owner.
- How much am I eligible from the Lyons Rebate program?
 - It depends; each household may receive a maximum of \$500 from the Town of Lyons but must first receive the Wildfire Partners rebate. You may not get paid twice for the same expenses.
 - Ex: You spend \$450 and receive \$450 from Wildfire Partners, you are not eligible for a Lyons rebate.
 - Ex: You spend \$650 and receive \$500 from Wildfire Partners, you qualify for up to \$150 from Lyons.
 - Ex: You spend \$3,000 and receive \$500 from Wildfire Partners, you qualify for up to \$500 from Lyons.
- Do I need to complete all mitigation activities on the same application?
 - Yes! Whether you complete mitigation from one area or many, you should submit all proof of work and receipts to Boulder County and not just \$500 worth of work. They help Lyons determine eligibility and ask that you submit all work on one application.
- Am I guaranteed money from the program?
 - The Lyons program is a first-come, first-serve model and runs until the rebate funds are all dispersed.
 - The Town will receive periodic updates from Wildfire Partners for residents of Lyons who have completed their assessment and claimed the Boulder County rebate. Lyons staff will compare this list to a list of those who have submitted the Lyons Rebate Application (this form) to determine priority in the program.
